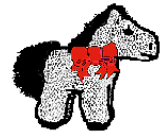




## ARTHAYASA CHRISTMAS SHOW 11th-12th DECEMBER 2010

## RULES & DEFINITIONS OR ENTRY

1. ALL ENTRIES – close of business Wednesday 8, December 2011. Entries are to be made with provided forms only. SMS entries are not accepted
2. LATE Entries: will be accepted after 8 December with a 50% late surcharge
3. CHANGE of entries: may be changed or substituted up to 5.00pm on the day prior to the competition.
4. REFUNDS: a 100% refund will be given on request – providing the scratching is made one (1) hour prior to the commencement of the specific class. Rp. 50,000 administrative charge will apply per refund.
5. WAIVER & LIABILITY FORMS: Waiver form must be signed by each rider participating in the event. Riders under the age of 18 must have guardian consent. To be returned with entry forms.
6. HORSE NUMBERS: Horse Identification Numbers are not provided by the organizer.

8. You must be an EFI member to compete (must hold valid EFI rider's license)
9. The Organizing Committee reserves the right at their absolute discretion to alter or amend any of the conditions, regulations, or any aspect of the event as they see fit.
10. Appeals: Complaints and appeals must be in writing to the Ground Jury, signed by the authorized person from the club, making the complaint and presented personally the appeal committee together with any supporting note evidence and names of witnesses and the deposit of Rp. 1,000.000,-. If the complaint is accepted OC will refund the deposit conversely if the complaint is not accepted the deposit will remain with the OC. Refer to the FEI Art. 167 Of General Rule & regulations for more details.
11. The competition is run under the latest FEI rules and Regulations unless otherwise stated in the class description.
12. The competition is run under the FEI Code of Conduct.
